Kelly also checked with Paul Wood to see how much a one mill millage would raise and it was \$38,000. This has been tabled to work on the grant.

**Fire Department/EMS**

Paid for radio batteries that will be reimbursed by 911 grant. Thanked Guy Swagart for his 20 plus years as Fire Chief as he retires.

EMS participated in a county wide drill that went well.
